Right to Financial Privacy Act

The Right to Financial Privacy Act established guidelines and procedures regarding how agencies of the federal government may obtain the financial records of certain customers. The Right to Financial Privacy Act covers requests for financial information regarding

Information Collected

Personal Information

Sensitive Personal Information

Is Personal Information that receives special legal protection under applicable law.
