

# Terms of Use & Privacy Policy

## Terms of Use

### **Personal Information**

SOC2 Type II Compliance ensures their systems are maintained at appropriate patch/system version levels through timely application of system updates. ### **Sensitive Personal Information**

Is Personal Information that receives special legal protection under applicable law. Access is limited to only sensitive PII needed to fulfill our services, and not to view or use sensitive PII for any purpose other than to fulfill this our required duties.
