2. RGC Lending Inc. is an administrative platform providing consumers the tools to easily search, apply and close a loan entirely online.
3. You apply directly with RGC Lending Inc.. RGC Lending Inc. controls the rates displayed, service providers and RGC Lending Inc. is the entity making a credit decision.
